Home Foreclosures and Neighborhood Action

Foreclosures: They hurt the people and families who loose their homes. They can hurt neighboring property by depressing home values. They can hurt neighborhoods by being potential safety hazards. They can hurt cities by reducing the tax base. And as we've seen, they can feed into a world-wide economic recession. At their March meeting, the Bottineau Neighborhood Association Board of Directors decided to do something about it. This is a bit of a long story and involves the use of some of the neighborhood's NRP dollars. If you want to cut to the chase, flip to page three.

A recent search of Realtytrac.com showed 1,148 foreclosed homes in the 55418 zip code and over 20 in the Bottineau neighborhood. While there is some good news in that some properties are being purchased, they generally are the ones that don't need a lot of work and are for the most part being bought by investors and not homeowners.

The City of Minneapolis Community Development Committee just approved almost \$6.5 million dollars in awards to nine nonprofit developers to do purchase/rehab work in certain areas of the City hardest hit by this whole issue. This still has to go to the City Council, but no changes are anticipated. To further complicate this, the Bottineau neighborhood is included in what is called a 'high need zip code' area. These areas were determined by the State. The County has identified other areas as 'high need'. Bottineau does

Spring really is just around the corner. And again, BNA is proud to coordinate the largest watershed clean up on the east side as part of the Minneapolis Earth Day Watershed Clean Up. Anyone and everyone is welcome to join us on **Saturday, April 18th at Gluek Park.**

5K Run / Walk

Start the day with a little exercise. Join over 100 others for a trip down Marshall Street, across the Mississippi twice and back. Refreshments available after. Registration for the 5K is required and those under 17 participate free. Treat bags guaranteed for the first 100 registrants.

Watershed Clean Up

After the 5K, stick around and help pick up trash, paint over graffiti, and clear debris from the river bank. This year we hope to cover nearly 500 acres along the river from Broadway to Xcel Energy. We can do more if there are enough people. Gloves and bags are provided.

If getting a bit dirty isn't your thing, feel free to hang around the Park and work on some art projects, build a bird house or meet a bald eagle and other birds of prey from the MN Raptor Center. The clean up won't cost you a thing but maybe a little hard work.

If all that wasn't enough, join us later that evening for a family friendly fashion affair at the Northrup King Building 3rd Floor Gallery. not appear to be included in that area. And, Minneapolis has designated a different and overlapping area for its NSP funds (Neighborhood Stabilization Program). Bottineau is also not included in that area. Of the nine nonprofits selected, only a couple appear to have proposed do work any work on the east side. Even if those that may actually do, the amount that appears available for eastside reinvestment is less than \$1 million, and that's if it is all directed to the eastside. The map and tables are a bit confusing. The CD Committee meeting referred to took place on March 10th.

To counter this, promote home ownership, and to create a greater incentive for the purchasing/rehab of those foreclosed properties that need more than some 'TLC' and 'elbow grease,' the BNA Board would like the neighborhood to weigh in on the use of up to \$70,000 of the neighborhood Phase II NRP funds (all that remain available and must be spent on housing). Specifically, the Board is putting the following proposal to the neighborhood:

Loan Amount: up to \$5,000

Loan terms: Zero percent interest; No monthly payment. The loan will be forgiven after five years. Prior to that, the loan is due on sale, transfer of title, when the primary mortgage is paid off, or when the property ceases to be the owner's primary place of residence, except in the case of a refinance.

Use of funds: The funds may be used to go toward either of the following uses: The payment of down payment, normal and usual closing costs, or repairs to the home. The borrower may not receive any portion of these funds as cash. Since the intent of the loan is to help buyers with their home purchase, the loan may not be used to reimburse a borrower for a purchase transaction that has already occurred.

> **Foreclosures**

Eligible properties must meet one of the following criteria: 1) be either a single-family home or a duplex that is in a foreclosed status, or was a foreclosed property that has been purchased by a non-profit for the purpose of selling it to an owner-occupant; 2) be on the Minneapolis 249 vacant and boarded buildings list; or 3) be a property that has been vacant for more than 30 days prior to signing the purchase agreement. There is no sale price limit and the homebuyer must occupy the home within 60 days following the home purchase closing, except that in the case of a home purchase and repair transaction, the homeowner must occupy the home within 60 days of the completion of the construction work.

A borrower's household income must not exceed 120% of the Minneapolis/Saint Paul metropolitan median income (about \$92,000 for a family of four). The borrower must qualify for and receive a traditional (prime or A-rated) fixed-rate first mortgage loan or purchase the property using cash. Cash buyers must demonstrate the financial ability to maintain the home within the same affordability standards as a prime loan recipient. Borrowers must complete homeownership counseling through an approved counseling program prior to closing of the loan.

Combined with the up to \$10,000 available through the Minneapolis Advantage Program and the up to \$8,000 for first time homebuyers from the Federal Government, the BNA Board feels this will be a nice incentive to draw homeowners to the neighborhood as well as those nonprofit developers.
